### STALLHOLDER INFORMATION SHEET

1	<u>Approved stall holders:</u> Catering Stall Holders applications will be notified if successful by 18 August 2023. General Stall Holders will be notified if successful within 14 days of receipt of application.
2	<u>Insurance:</u> Trade Space Occupiers and Stall Holders are required to provide their current Certificate of Currency for Public Liability Insurance up to \$ 10 000 000 on application.
	* <u>Public Liability:</u> A copy of your current <u>Certificate of Currency</u> for Public Liability must accompany your application. Application will not be approved until certificate is received.
	* <u>Stall Holders</u> participate at the Bindoon Show at their own risk and are required to indemnify and hold harmless the organisers against any claim for damages, costs, claims, expenses and liabilities including without limitations consequential loss and loss of profits in respect of any loss, damage, injury, disease or death caused through any of the Stall Holders activities at the Bindoon Show.
5	<u>Set Up:</u> Stall Holders will have access on Friday 13 October 2023 BETWEEN 2.00pm - 6.00PM or Saturday 14 October 2023 from 7.00am to 9.00am. No vehicles will be given access after 9.00am on Show Day
6	<u>Cancellations &amp; Refunds:</u> Stall fees will not be refunded should inclement weather or factors beyond the control of the Bindoon Show organisers affect the event. No refunds will be given for cancellations made less than 21 days prior to the Show.
7	<u>Product Exceptions:</u> <u>For safety reasons no guns, cap guns, laser pointers, knives (except kitchen knives), explosive devices or any toy capable of firing a projectile will be permitted on the show grounds.</u> Grounds staff will inspect merchandise and failure to comply may result in expulsion from the grounds.
8	<u>Site Location and Assessment:</u> Bindoon Show organisers reserve the right to refuse any applicant to maintain the spirit of the event or change stall locations without notice.
9	<u>Approved Food Vendors:</u> Vendors must have a current Food Registration Certificate and a copy of this must accompany this application, along with a Temporary Food Business Application. This permit and application will be forwarded to the Shire of Chittering's Principal Environmental Health Officer for approval.
10	<u>Non Registered Food Businesses:</u> Temporary Food Stalls must complete and enclose the Shire of Chittering Temporary Food Business Checklist and a Temporary Food Business Application. See Principal Environmental Health Officer at the Shire of Chittering Ph 9576 4614, eho@chittering.wa.gov.au for more information.
11	<u>Fitout:</u> Stall Holders are to provide their own tables, chairs and weather protection (shades, tents etc). Stall Holders must provide their own weights or methods of securing shelters. Stall Holders are responsible for the erection and dismantling of their own shades, within the designated area. <u>Please ensure anchor points are within your booked site.</u>
12	<u>Electricity:</u> Stallholders that intend to use a powered site shall ensure all power leads and electrical appliances, to be used on the day have a current tag issued by a licensed electrical worker. The tags must be visible, legible and attached to the electrical item before the event. There will be an electrical service to have items tagged onsite at the cost of \$25 per tag.
13	<u>Parking</u> is not available on the grounds. You must unload your goods and remove your vehicle to the designated Stall Holder parking area before 9.00am. If you require a site for your vehicle displays please book a site large enough to accommodate it safely and without intrusion on other Stall Holders (including draw bars).
14	<u>Show Hours</u> are from 10am to 4.00pm on Saturday 14 October 2023. Stall Holders are to be set up and ready to commence trading at 9.45am.
15	<u>Rodeo Hours</u> are from 4.30pm to 8.00pm
16	<u>Band Hours</u> are from 8.00pm to late
17	<u>Final Instructions:</u> Successful Stall Holders will receive Final Instructions for the day prior to the Show
18	<u>Dogs:</u> No dogs are allowed anywhere on the grounds (including Stall Holder sites). <u>Competing dogs are exempted.</u>
19	<u>Alcohol:</u> No BYO alcohol is allowed anywhere on the grounds
